PURPOSE OF REPORT	For discussion and recommendation to the full Fire Authority
EXECUTIVE SUMMARY	The structure of the prevention team has been designed to be able to continue to deliver a range of youth intervention and education programmes to assist in meeting the vision and priorities of Dorset & Wiltshire Fire and Rescue Authority. In recent years these programmes have been variously funded by local authorities and other public, voluntary and private sector organisations and in part by the previous fire and rescue services. This funding has been increasingly difficult to secure in many areas due to continued reductions in the spending power of many of these commissioning organisations. In order to ensure that we are able to put clear plans in place to support the continued delivery of our programmes, it is proposed that finances are allocated to cover some of the delivery costs within the Medium Term Finance Plan (MTFP). This will allow the Dorset & Wiltshire Fire and Rescue Service to consolidate its position in terms of contributing to positive outcomes for some of the most vulnerable young people across Dorset and Wiltshire.

1. Introduction

- 1.1 In order to meet the vision and priorities of Dorset & Wiltshire Fire and Rescue Authority, the structure within the prevention team has been designed to ensure there are sufficient resources to enable the range of youth intervention and education programmes we deliver across both Counties to continue.
- 1.2 This reflects the view of Member's who have previously expressed their support for the programmes we deliver at a number of seminars that have been held during the period when the Fire Authority was in shadow form.
- 1.3 This is also considered to be particularly important as our programmes are widely admired by our partners and they have been shown to be able to deliver positive outcomes for some of the most vulnerable young people.
- 1.4 They are also a key element in trying to ensure that young people across Dorset and Wiltshire are provided with relevant education opportunities to make sure they understand the risks they face from fire, on the roads and in wider society.
- 1.5 Our youth intervention and education programmes are also complimented by the design and delivery of activities and events through the safety centres we support with our partners and key stakeholders.
- 1.6 The table below provide a summary of the main programmes we deliver with indicative costs.

2. Costs and budget provision

- 2.1 The costs indicated against each of the programmes shows the full costs associated with delivering each event. In recent years both Dorset Fire and Rescue Service and Wiltshire Fire and Rescue Service have, in some cases, subsidised these costs. This has either been through the use of residual grants or through making provision within their respective revenue budgets.
- 2.2 The proposed delivery of programmes and events for 2016/17 are set out in Appendix A. This shows that in the Wiltshire County Area 18 events are planned. For Salamander courses the full costs associated with an event are £8333. In the table some income is

shown as being below this figure. The difference in the full costs and the income is proposed to be picked up by the Service (as has been the case in recent years). Other courses are shown as being fully funded by the Service.

2.3 The difference between contributions and actual costs is therefore shown as being £46,197.80 if the full programme of events is delivered. In the Dorset County area the shortfall in costs against proposed events is approximately £50,000. The combined shortfall is therefore just over £96,000.

3. Course alignment and Prince's Trust

- 3.1 As part of the convergence work that is planned across the new Service we will be looking at how we can align the existing youth intervention and education programmes. This will include evaluating both the most appropriate delivery methods, which will be aligned to local partner needs, and the internal resource requirements and methods of delivery.
- 3.2 In some areas, such as the Cadet's programme that runs in Cricklade, the review will focus on how Dorset and Wiltshire Fire and Rescue Service can continue to support the programme rather than seeking to change something that clearly meets local needs.
- 3.3 Another key area within this review will look at the opportunities that exist for the new Service to support the delivery of Prince's Trust programmes. Dorset Fire and Rescue Service had a long standing relationship with the Princes Trust, having delivered well over 100 team programmes. For the majority of the time that the programmes were running the team programmes could evidence very high rates of positive outcomes for those who completed the programme.
- 3.4 However, more recently the young people who have been attending these programmes have increasingly had more complex social, and in some cases, mental health issues. This has led to a number of occasions where the safety of those attending programmes and/or staff members has been at risk.
- 3.5 As a result, it was considered appropriate to suspend our delivery of the team programme in the short term to provide the capacity to re-evaluate whether there are other Prince's Trust programmes that the new Service might be able to support (outlined in Appendix B). It also offers the opportunity to review how these programmes might complement the other youth intervention and education programmes we will deliver in the future.
- 3.6 We have already met with the regional business manager for Prince's Trust programmes and their lead for Fire and Rescue Services to start to develop a delivery plan for the new Service.
- 3.7 This approach also offers the potential to try to develop a pathway to employment through our youth intervention and education programmes (including the Prince's Trust programmes) that might also be able to be linked to our approach to apprenticeships in the future. As part of the review we are also looking at the fire sector to learn from other

Service's experience in this area. This work is being undertaken by the Education for All Manager and a report will be brought to members in the next few months.

4. Summary

- 4.1 Our Youth Intervention and Education programmes are well respected by partner agencies and they have a track record of delivering positive outcomes for some of the most difficulty to reach young people.
- 4.2 Funding from partners to support these programmes has been more and more difficult to secure. As a result the two previous services have supported the delivery of events financially to a greater or lesser extent.
- 4.3 The recommendation aims to ensure that programmes can continue to be delivered during 2016, while officers review the delivery plan for future years.
