EXECUTIVE SUMMARY	At its December meeting the Wiltshire and Swindon Fire Authority requested that the suggested terms of reference for the Combination Oversight Board may need to be further clarified and refined. Following the inaugural meeting of this advisory Board, revised terms of reference have been developed. The proposed revisions provide for greater clarity with regards to voting rights and to the advisory nature of the working group.

1. Introduction

- 1.1 Members will recall that at a previous CFA meeting on 12 December 2013, a Paper was presented regarding a proposed combination between Wiltshire FRs and Dorset FRS.
- 1.2 Approval was given that both Services could look towards the viability of a combination, through the development of with a full Business Case brought to their respective CFA in September 2014.
- 1.3 The decision on whether the two Services should progress towards combination would be made at the September 2014 CFA meeting.

- 1.4 Within the Paper of 12 December 2013, it was identified that whilst moving towards a decision for combination and working through a proposed convergence programme, there would be need for a joint Oversight Board, comprising of Members and Officers from both Authorities, whose purpose is to scrutinise and/or review the strategies, policies, plans and resources of the project. This Board would be an advisory body to the two Combined Fire Authorities.
- 1.5 The CFA Paper of 12 December detailed suggested Terms of Reference (ToR) for this Oversight Board (Appendix B of that Paper).
- 1.6 At the CFA meeting of 12 December, Members made recommendation for some slight changes to those draft ToR and these have now been incorporated and the revised ToR are presented below for approval by the Combined Fire Authority. It was also agreed that this Oversight Board should be call the 'Combination Oversight Board'.

2. Combination Oversight Board - (COB)

2.1 The Board is an advisory body set up by both Authorities. The expectation is that decisions will be reached on a consensus basis without the need for a vote. In the event of a vote becoming necessary, the decision will be made by the majority of elected Members present at the meeting. Officer advisors shall not be entitled to vote.

Terms of Reference

- 1) Provide strategic political direction to the joint leadership team in relation to the combination programme and emerging public policy and spending
- 2) Recommend to the respective Authorities a joint vision

- 3) Consider critical governance issues associated with the combination programme and advise the respective Authorities as required
- 4) Develop a business case for possible combination. This to be considered in September 2014
- 5) Consider and recommend shadow arrangements to respective Authorities for the political and managerial governance of combined functions through a single Authority
- 6) Oversee the establishment of central governance arrangements for managing combined functions including a potential trading arm
- 7) Approve the scope, milestones and deliverables of the combination programme.
- 8) Monitor and approve periodic programme updates that will be subsequently considered by both Authorities.
- 9) Approve and monitor a communications strategy for the combination programme ensuring sound relationships with relevant political stakeholders
- 10) Approve and monitor the programme risks, issues and benefits
- 11) Within the agreed budget set by the Fire Authorities, monitor financial expenditure to support the convergence programme
- 12) Recommend to the respective Authorities grant applications including a joint transformation bid to DCLG for 2015/16

6. Significant Risks

6.1 Failure to adopt a clear terms of reference for the Combination Working Group will lead to poor governance arrangements associated with the due diligence process and the development of the business case for combination.
