## 1. Introduction

- 1.1 The Dorset and Wiltshire Fire and Rescue Authority (Combination Scheme) Order 2015 sets out the entitlement of the five constituent councils Bournemouth Borough Council, Dorset County Council, the Borough of Poole, Swindon Borough Council and Wiltshire Council to places on the Dorset and Wiltshire Fire and Rescue Authority (DWFRA).
- 1.2 The constituent councils have made the following appointments to DWFRA:

- 2. Representation on the Authority
- 2.1 The rules on political proportionality under the provisions of the Local Government and Housing Act 1989 apply to committees of the Authority. If the political affiliations of members of the constituent councils appointed to DWFRA were to be replicated in groups formed on DWFRA then the group memberships and percentage entitlement to places on Committees would be as follows:

Conservative – 20 (66.6%) Liberal Democrat – 5(16.6%) Labour – 4 (13.3%)

Total = 29 - there is in addition one independent member.

- As at the time of preparing this report a Conservative group and a Liberal Democrat group had been formed but no Labour group. This means that unless a Labour group is formed in time for the DWFRA meeting on 1 April 5 members of DWFRA are likely to be ungrouped and members will have to decide how places on committees are to be allocated so as to best reflect the overall composition of the Authority.
- 2.3 At its meeting on 23 October the Shadow Authority agreed the governance arrangements for the new authority and agreed to establish the following committees:
  - Policy and Resources Committee membership of 12
  - Finance and Audit Committee membership of 12
  - Appeals Committee membership of 10
  - Local Performance and Scrutiny Committees comprising local members.
  - Appointments and Disputes Committee a panel of 5 members drawn from all members of the Authority as and when the Committee needs to meet.
- 2.4 Under the arrangements that were agreed on 23 October the Policy and Resources Committee, Finance and Audit Committee and the Appeals Committee would be appointed to in accordance with political proportionality. Local Performance Committee places would be filled by DWFRA members drawn from the area of the relevant constituent council or councils and the Appointment and Disputes Committee would be appointed to by group leaders when the need arises.
- 2.5 The entitlements to places on committees of the Authority for 2016/17 (depending upon the formation of a Labour Group) is as follows:

Finance and Audit Committee (12)	8 places	2 places	2 places
Appeals Committee (10)	7 places	2 places	1 place

- 2.6 If five members remain ungrouped then the Authority will need to decide how best to allocate what would otherwise be Labour places on the three main committees.
- 2.7 There is to be a delay before the first meetings of the Policy and Resources Committee and the Finance and Audit Committee. During this time officers will need to begin working with the committee chairmen and so the Authority is asked to appoint the two chairmen now rather than wait until the first meetings at which the committees would otherwise elect their own chairmen.

# Local Pension Board

- 3.1 Under the new Firefighters' Pension Scheme Regulations 2015, the Authority is required to have a Local Pension Board in respect of the Firefighters Pension Scheme. The role of the Board is to help ensure the Firefighters Pension Scheme complies with governance and administration requirements, as well as any other duties the Authority may so wish the board to have.
- 3.2 At its meeting on 23 October 2015 the Shadow Authority deferred to this meeting consideration of the arrangements to establish a Local Pension Board. In the meantime Workstream 1 has supported the establishment of a Local Pension Board comprising 4 elected member representatives and 4 employee/pensioner representatives, a total of 8.
- 3.3 Members are now asked to agree the establishment of the Local Pension Board for DWFRA and to appoint 4 elected member representatives to the Board.

# 5. Member Champions

  - Response Desirable
  - Asset Management Desirable
  - Retained Duty System Desirable
  - Protection Optional
  - Governance Optional
