PURPOSE OF THE REPORT	For Approval
EXECUTIVE SUMMARY	At the meeting of the Authority on 1 April, Members requested Officers to develop an arrangement where members were allocated to Stations on a buddy system. It was agreed that this and outstanding nominations for committees and appointment of member champions would be considered by Policy & Resources Committee.
	Appendix A provides the draft work place visits protocol which includes guidance and allocation of Members to workplaces.
	The protocol encourages Members to keep a strategic focus during the visit, and in particular to comment on the working environment, performance management and staff morale.
	In terms of station visits, the whole-time stations have four watches, and sometimes a retained section as well, whereas a totally RDS stations will have 'one shift', the day-crewed stations have two watches and sometimes a retained section and hub stations have a whole-time watch for day cover with an additional retained section.
	Therefore, some Members are only allocated one station, whereas others are allocated a number stations dependant upon crewing type.
	The station allocations attempts to align DWFRA Members, where possible, to stations in their wards or neighbouring wards, although of course this is not always possible.
	Whilst it is possible to accompany Members (particularly new Members) during these visits, this is not obligatory and the protocol includes a contact list for Members to use to arrange visits independently.

	Appendix B, Committee Memberships, provides Members with the committee memberships agreed at the Fire Authority meeting on the 1 April and highlights (in orange) the outstanding committees requiring nomination and appointment Appendix C provides Members with a list of the member champion roles, requiring Member appointment.

Appendix A

Workplace Visits Protocol

Introduction

The Fire Authority agreed, in their inaugural meeting on the 1 April 2016, to align DWFRA members to stations within DWFRS. Attached in pages 4-8 is a list of DWFRS stations with a brief explanation of duty systems worked.

It is agreed as beneficial to allocate Members to particular stations and then ensure the Member has the contact number of the local manager and/or Head of Department to arrange their visit.

Whilst it is not considered necessary (unless a request is made) for Members to be accompanied by a Principal Officer, it is desirable that in addition to contact with the appropriate manager, the CFO is also kept informed (via Jill McCrae - jill.mccrae@dwfire.org.uk). Quite apart from attempting to balance visits by Members to stations, knowledge of planned visits will also ensure that planned visits by Principal Officers and other visitors is scheduled to provide a balance amongst all staff.

To assist with the visits and develop a consistency an aide memoir and feedback mechanism has been put into place. This is provided on page 9.

In terms of station visits, I would encourage Members to ensure that as part of the visit they spend some time becoming familiar with the Fire and Rescue Service business and effectiveness in the station area by discussing with the officer in charge the performance information.

There is no schedule or frequency detailed in this proposal, but it is suggested that visits to each workplace occurs at least once and no more than three times per year.
